As you listen, it is often a good idea to write down important information the customer is giving you. Also, this practice will help you in dealing with the customer and will enable you to summarize events as you talk with them.
- B. BE POLITE This is very important. Customers can become abusive and many say or imply almost anything in the heat of an argument. It is difficult, but it is very important to remember not to take this kind of behavior personally. When Atari receives complaints involving service, the first complaint is usually that they were treated rudely. Always try to be gracious and polite; try to treat your customers the way you would like to be treated.
- C. EXPLAIN YOUR POSITION AND/OR SOLUTION Once you know what the customer complaint involves, you can calmly explain your company's position and/or solution to the problem. If the customer is still dissatisfied; <u>call us for help</u>. That is why we are here.

SPECIAL NOTES

A. In-Warranty Repairs

Unless otherwise specified, Atari's products carry a 90-day warranty. The warranty period normally starts from the date of purchase. Since many of our customers receive their Atari units (games, cartridges, etc.) as gifts during the Christmas season, some problems can arise. Examples of these problems include:

- 1. No receipt
- 2. They have a receipt, but the unit was purchased weeks or months prior to it being opened as a gift.

<u>Solution</u> - You will be notified by mail each year, prior to the Christmas season as to our policy and how it is to be administered. If you are inadvertently not notified, or if you have questions concerning problems of this nature, call us immediately. Your local Regional Office will be able to help you.

B. Out-of-Warranty-Repairs

Atari has out-of-warranty pricing which may be lower than what your establishment charges. Our repair/replacement charges, in some cases, are clearly stated on either the product literature or warranty card. We honor the stated prices. Some of your customers may become upset if they are expecting their unit to be serviced at our stated price. You should politely inform them that your prices are determined by you and that only Atari honors service charges stated on product literature.

How to Handle - You can further explain that in most cases the differences are small and not worth the mailing, insurance and delay involved in sending their items to an Atari location. NOTE: When customers call us, we do not tell them what our prices are unless they ask. If the customer inquires, we are obliged to tell them.

C. Irate Customer

Occasionally you may encounter customers who are so upset or dissatisfied that communication is non-productive. These customers do not go away after they leave your establishemnt. Most of the time they pursue their grievance by contacting either Atari/Warner corporate officers or other third parties (news media, consumer groups, etc.). In the end we handle these customers. Most problems can be avoided if you contact us early, before the customer becomes irate.

D. Repair Delays

Parts Delays - We have experienced some difficulties with customers who have become irate when, after several weeks of delay in getting their unit serviced, they learn that you cannot repair the unit until you get the part from us. This is an unncessary problem.

Solution - The customer should be notified immediately if a delay due to parts shortage is expected. If you experience problems obtaining parts within a reasonable time period, or if you regularly have parts problems, you should document these and inform your Regional Field Representative.

2. Backlog Delays - Once again, most problems can be avoided if the customer is initially told how long the repair is expected to take. Many service centers put a date on the customer's claim slip to avoid misunderstanding as to when the unit will be ready to be picked up.

WARRANTY CLAIM FORM PROCEDURE

Each ATARI **WARRANTY CLAIM FORM** (Exhibit A) must contain the following information (circled numbers on Warranty Claim Form correspond to numbers below):

- 1. Customer's full name, mailing address (including Zip Code) and home phone number (including area code).
- 2. Service Center's account number.
- 3. Model number of the unit being repaired. If repairing a <u>Video Computer System (VCS)</u> or Super Game System (5200) unit, enter <u>one</u> of the following model numbers:

- 13. Explanation of service performed.
- 14. Date the product was purchased (MM, DD, YY)

NOTE: The servicer is required by the terms of the agreement to verify that the product is within the limited warranty period or under extended warranty by evidence supplied by the consumer as to the date of purchase of the unit or service contract.

If the consumer indicates that the unit was a gift and the servicer determines that the unit is in reasonably good condition, repair the unit and enter "GIFT".

If repair of store or dealer stock is done, enter "STORE STOCK" or "DEALER STOCK". Multiple Store or Dealer Stock claims must be pre-approved by calling your local Regional office. These claims must be submitted on a separate summary and then be mailed to your Atari Regional Office.

A concession code must be obtained by phone from your local Regional Office for any claims submitted for payment on repairs done outside of the initial warranty period. Your Region may feel a concession is in order in special situations. If so, the Region will authorize repairs and provide you with a concession code which should be recorded in the purchase date field of the Warranty Claim Form (refer to Exhibit A).

- 15. Date the service was requested (MM, DD, YY). Enter the date the unit was received for repair.
- 16. Date the service was completed (MM, DD, YY).
- 17. Time the repair was started by the technician.
- 18. Time the repair was completed by the technician.

- 27. Include your incurred freight charges when the unit is shipped back to the customer freight prepaid. Indicate the method of shipment in the customer signature area of the form (Field 29 Exhibit A) and record the date shipped (Field 30).

- 28. Total of labor, parts, and freight prepaid to customer (add Fields 25, 26, & 27).
- 29. Customer signature or method that unit was shipped back to customer (i.e., UPS, US Mail, etc.).
- 30. Date customer picked-up unit or date unit was shipped to customer.
- 31. Technician signature.
- 32. Date of technician signature.
- 33. Service Center's name/address stamp.
- 34. The Customer Claim Check (tear-off goldenrod) is completed when service is requested. Be sure to include your company's name and the date the unit will be ready for pick-up.

*Please refer to your Service Contract Policy Manual for more specific information.

The Warranty Claim Summary number above the service account number will be the reference tied to the reimbursement check.

Each Atari Warranty Claim Summary must contain the following information (circled numbers on Exhibit F correspond to numbers below):

- 3. Date that claim is submitted.

Narda Forms (Exhibit I) may be used in place of the Atari Warranty Claim Form (Exhibit A), when submitting warranty claims. Atari will not supply you with Narda Forms. If you prefer to use the Narda Form, please refer to the procedures for completing the Warranty Claim Form as the same field descriptions and instructions apply. SUBMISSION PROCEDURES FOR NARDA FORMS

Narda Forms must be summarized on the Warranty Claim Summary (Exhibit F) and submitted at least monthly with copies of each Narda form (Exhibit I).

Invoice copy distribution will be as follows:

- 1. Both the white and canary copies of Narda form (Exhibit I) and the Warranty Claim Summary (Exhibit F) must be submitted with the required defective warranty parts to the Warranty Parts Return department. Use preprinted labels supplied by Atari (Exhibit E).
- 2. <u>Pink</u> copy of Narda form must be retained by servicer for questions regarding claims.
- 3. Goldenrod copy of Narda form must be provided to customer when repair is completed.

NOTE: Refer to Submission Procedure for Warranty Claims for:

- o General claims submission information
- o Mailing claims and defective warranty parts to Parts Return Department
- o Returning defective part
- o Rejection of claims
- o Rejection of shipments

SUBMISSION PROCEDURE FOR WARRANTY CLAIMS

1. General Information

- o Claims for warranty reimbursement must be summarized on the Warranty Claim Summary (Exhibit F) and submitted at least monthly with copies of each Warranty Claim Form (Exhibit A) attached.
- o The Summary Claim number above the service account number will be the reference tied to the check.
- o All parts listed on Exhibit C & D must be returned with the respective warranty claim packages.
- o You may replenish your supply of Warranty Claim Forms, Warranty Claim Summary Forms and preprinted labels by placing an order with the Parts Order Department.
- o Warranty billings will not be accepted if the date indicated on the Warranty Claim form, as the date of repair, exceeds 60 days from the date of submittal.
- o Submit separate Claim Summaries for VCS 2600 Series, VCS 5200 Series, and HCD warranty repairs.
- o Occasionally a unique warranty situation may arise which may not be covered in your policy manual. Should you have questions, contact your local Regional Office. Any claims which you submit that are outside of the terms and conditions of the agreement must be sent to the Regional Office serving your area. Include a complete written justification of any such claims and be sure to submit them on a separate Warranty Claim Summary Form. The Region will forward your claims to the Warranty Claims department for payment consideration.
- o Atari reserves the right to conduct audits of any claims submitted for reimbursement. Any such claims which are not properly substantiated and do not meet the terms and conditions of the agreement will be debited back to the Servicer.

2. Invoice Copy Distribution

- o White and Canary copies of both the Warranty Claim Form (Exhibit A) and Warranty Claim Summary (Exhibit F) must be submitted with the Defective Parts to the Warranty Parts Return Department. Use preprinted labels supplied by Atari (Exhibit E).
- o <u>Pink</u> copy of both the Warranty Claim Form (Exhibit A) and Warranty Claim Summary (Exhibit F) must be retained by Servicer for questions regarding claims.
- o Goldenrod copy of Warranty Claim Form (Exhibit A) must be given to customer when repair is completed.

- 3. Mailing Claims to Parts Return Department
 - o White and Canary copies of both the Warranty Claim Form (Exhibit A) and Warranty Claim Summary (Exhibit F) must be submitted with the Defective Parts to the Warranty Parts Return Department.
 - o Use preprinted labels supplied by Atari (Exhibit E) for the return of defective parts only.

NOTE: These labels are <u>not</u> to be used when returning whole product to the Region for repair, or when returning parts under the RMA procedure.

- o Place your <u>Return Address</u> on each box submitted to Warranty Parts Return Department.
- 4. Returning Defective Parts to Parts Return Department
 - o Service Centers will be reimbursed for parts used in the repair of warranty products, at the established current wholesale price. Return to Atari for reimbursement all parts listed on Exhibit C and Exhibit D that were used for Warranty Repair. Use preprinted labels supplied by Atari (Exhibit E). The return address is:

- o Warranty parts will be reimbursed, not replaced. You must re-order parts as needed. (Refer to Section VIII, Parts Ordering Procedure.)
- 5. Rejection of Claims

NOTE: Please be advised that Warranty Claim Forms will automatically be rejected for one or more of the following reasons (Exhibit G):

- o Customer name and/or address missing or illegible.
- o Serial Number, Model Number, Manufacturing Site, Date Code, Purchase Date missing.
- o Lack of customer signature on claim form (unless shipped).
- o Neglect to list parts used in repairs with quantity and price on individual Warranty Claim Form.
- o Explanation of work performed on claim form.
- o Neglect to list on Summary and/or return of required defective parts

- o VCS 2600 Series, VCS 5200 Series, and HCD Warranty Claim Forms submitted on one Warranty Claim Summary Form.
- o Service Contract claims and in-warranty claims submitted on one Warranty Claim Summary Form.
- o Submission of out-of-warranty or duplicate claims.
- o Lack of concession codes or appropriate authorization for "board swap".
- o Claim includes unauthorized software or non-Atari parts not authorized for parts reimbursement on Warranty Claim Form.
- o Claim includes initially defective parts (DOAs) not authorized for parts reimbursement on Warranty Claim Form (refer to Section VI, Defective Parts Handling).
- o Submission of claims on units not endorsed for repair.

NOTE: Claims that do not meet contracted rates should be submitted to the Atari Regional Service Center on a separate summary for payment consideration. A written justification must accompany such claims.

6. Rejection of Shipments

NOTE: Please be advised that the Parts Return Department will automatically reject shipments for one or more of the following reasons (Exhibit H):

- o Shipment received without Warranty Claim Summary Form and Warranty Claim Form(s).

 - c. Label the box in which the unit is shipped to the Atari Regional Service Center "In-Warranty Repair".
 - d. Include the Service Center name and address on the box.
- 3. Atari will repair and ship the unit back to the Servicer (freight prepaid) with both the white and canary copies of the Warranty Claim Form. Additionally, a copy of Atari's shop invoice will accompany the unit.

4. The Warranty Claim Form, accompanied with the Atari shop invoice should be submitted on the next Warranty Claim Summary for reimbursement of the Package and Return Handling fee.






